Re: TCRC v. CP Rail – Strike Notice

Dear Sir,

The purpose of this letter is to provide you with sufficient strike notice in the event that our negotiations do not result in an agreement prior to 23:59 of February 14, 2015. This notice is on behalf of the Teamsters Canada Rail Conference (TCRC), inclusive of each of the General Committees of Adjustment representing Locomotive Engineers, Conductors, Trainmen, and Yardmen, which collectively represent the entire bargaining unit of such various crafts at CP Rail.

This is to advise you that effective 0001 (hrs.) EST, February 15, 2015, in the event there is not a negotiated settlement between the parties at that time, the entire bargaining unit consisting of approximately 3100 TCRC members will be exercising the right to take legal strike action throughout each terminal in Canada where bargaining unit members are employed.


