This is with regard to our ongoing discussions, relating to a National Application of “Rest after Annual Vacation”.

After a thorough review of the issue across the system and in the interest of harmonious labour relations, the parties agree that employees may choose to request rest after annual vacation, in line with the language and associated principles contained in Appendix A (attached).

Of course, this agreement is reached on a without precedent or prejudice basis and may be cancelled with 30 days notice by either party. In the event that notice is served, the parties must meet within 7 days in order to address any issues.

Upon your concurrence, please sign in the space provided below and return one copy for our records.



Appendix A

1. National Rule – Booking-On From Annual Vacation

1.1 Crew change for all terminals will continue to take place at 22:01 - Sunday night for broadcast at 00:01 - Monday, or in some cases, 00:01 - Monday for 02:00 - Monday.

1.2 An employee may, at his/her discretion, choose to request rest after annual vacation, and this request must be received by the CMC no later than 15:00, Sunday afternoon, prior to crew change. When the request for rest after AV is received, standard rest until 0400 Monday will be applied, with the employee entitled to a standard call, at or after, 0600 Monday.

1.3 Should an employee choose not to request rest after annual vacation, standard calling time protocols will apply.

1.4 This rule may be cancelled with 30 days notice by the General Chairmen (East and/or West) or the Director, Labour Relations. Should notice be served, the parties will meet within 7 days to address any issues identified.
